Drug Testing Adminstration Acknowledgement/Conent Form The Hall County Board of Education has authorized amndatory random drug test for all student-athletes how participate in Georgia High School Association (GHSA) Inter-scholastic athletics and all students who obtain a compus parking permit.

Specimens will be processed for identity and secured to ensure against tampering. Thest results will be reported to the school through the proper chain of command. In case of a positive result, the paretn or guardian will be notified.

Testing will be done by the Northeast Gerogia Forensic/Toxicology Lab under the supervision of the Toxicology Program Manager.

This acknowledgement of administration and consent to allow participation in the random drug-testing program shall remain in effect until revoked in writing.

JOHNSON HIGH SCHOOL PARKING REGULATIONS

A PARKING PERMIT DECAL MUST BE PURCHASED BEFORE A STUDENT DRIVES A VEHICLE ONTO THE JOHNSON HIGH SCHOOL CAMPUS

Students who have purchased a parking permit decal must park in their designated parking space. Designated parking space is the same number as our permit decal number. In order to purchase a decal you must present a valid driver's license, proof of automobile insurance and a completed permit application. You must register all vehicles you ight drive onto school campus and furnish complete information for each vehicle

THE COST OF THE PERMIT IS \$60.00 REPLACEMENT COST IS ALSO \$60.00

Any student who drives on campus without a permit decal OR parks his/her vehicle in any space other than his/her designated parking permit space will be subject to the following penalties.

1st Violation: Warning2nd Violation: \$5.00 fine or 1 day ISS3rd Violation: Loss of permit OR loss of obtaining parking permit for the remainder of the current semester.

Any student who drives on campus after his/her permit is revoked will be subject to the following penalties:

1st Violation: 1 day of school suspension or 2 days of ISS.2nd Violation: Referred to SRO3rd Violation: Suspension from school until parent conference4th Violation: Loss of permit for remainder of the current school year.

Please be aware that your vehicle is subject to be searced at school. It may also be towed if a situation warrants.

FIVE (5) UNEXCUSED TARDIES TO SCHOOL WILL RESULT IN LOSS OF PARKING PERMIT FOR THE REMAINDER OF THE CURRENT SEMESTER. (CHECK"TARDY TO SCHOOL" SECTION FO STUDENT HANDBOOK FOR OTJER CONSEQUENCES.)

Students who withdraw or graduate early from JHS must turn in parking decals to the Counselors Office.
